Sexual Harassment Prevention Training Compensation

MPFA has negotiated a Memorandum of Understanding (MOU) with the district to more fairly compensate those people who took the required training last semester, and were compensated only \$25.00. All part-time faculty who chose that option will now be compensated for one hour at their hourly instructional rate. The differential between that rate and the \$25.00 will be in your March 2020 paycheck.

MPFA's letter of intent to negotiate a new contract with the District will be presented to the Board of Trustees at their February 5th meeting as part of the Consent Agenda. It will remain subject to public comment until the March 11th BOT meeting, after which we will begin contract negotiations. MPFA and the District have thus far agreed to five bargaining sessions in the spring semester.

In our bargaining, we will be using the feedback we received from the part-time faculty survey, as well as any other information and concerns we receive from our part-time faculty colleagues.
